Newport Construction is set to start repairs on garage next week. Our guys have been working on installing water main on 6th Ave before Borough resurfaces the road. Per previous discussion with Mr. Buscher about opening the office to the public in mid July, the appropriate COVID-19 signs have been purchased in preparation of opening. Mr. Buscher stated that we will close the office again if it seems the opening doesn't appear to be working or if there is any danger to the employees. Mrs. Corson said that even though Governor Murphy passed a law permitting Authorities to waive interest charges. Mr. Long stated that the law is written that we must maintain consistency in waiving fees for all not just one. The Board discussed the fee waiver and agreed a BLANKET NO decision.

WHEREAS, the Authority has determined there exists a need within its service area to undertake capital improvements to its Water System, consisting of: (i) the rehabilitation of the Erial Road Water Main; (ii) installation of a backup well for Well #4; and (iii) decommissioning of Well #6 and Well #7, all as more particularly described in the information on file in the offices of the Authority and the Authority's Consulting Engineer and available for inspection during normal business hours (collectively, the "Construction Project"); and
